Service Package and Benefits

The mobile patrol service may vary from Zone to Zone (according to the number of households which are enrolled as members). In most cases, the service begins at 11pm and ends at 7am. However, we also have 24-hour service for certain areas which request for it and have sufficient membership numbers. Patrolling personnel will look out for strangers and those behaving suspiciously while on their rounds. They will also shine their torchlight's in dark areas and members' homes. High-risk areas will be identified and monitored. Always use the Call Centre-Helpline No. 03-3373 3994.

When you become a Homeguard member, you also get the Homeguard Assist package which provides you many benefits and advantages:

1. Quick-Response Team to rush to your house in case of emergencies. (Service hours only).
2. 24-hours Call Centre convenience (03-3373 3994).
3. Tiger Eye – if you are going away or on holiday, inform us in advance and we will keep an extra eye on your house. We will report to you. (In case of emergency)
4. Escort Service – If you are returning home and suspect someone is following you or you see strangers at your gate, call us and our men will escort you.
5. Outrider service for funerals (special charges)
6. Gentlemen guards for functions i.e. weddings, parties (subject to a minimal charge).
7. Two Tiger Eye stickers given free for your car to enable your vehicle to be identified as belonging to a Homeguard member. Additional stickers will cost RM1.20 per piece.

Payments

Your monthly fee of RM40.00 will be collected by authorized bill collectors displaying the company tags. You need to pay upon signing up as a member. An official receipt will be issued. Membership identification is very important. Always refer to the ID when making enquiries. No temporary receipts issued.

Terms and Conditions

- Any breach of security will be attended to promptly and professionally. If it is beyond our control, we will alert the police. However, we cannot guarantee that crime will not occur.
- We will not be liable for vehicle windscreens being smashed, especially those parked at the road shoulder.
- Homeowners should have their own burglary insurance policy. Sri Lara Homeguards will not pay any compensation for burglaries and losses incurred.
- Non-payment of monthly fee for 90 days will be deemed an inactive account and terminated.
- This form must be filled up by members so that we can key the information into our customer database. All information will be kept confidential as the database is password-protected.
